## **IATF MISSION**

The Inter-Agency Task Force on Israeli Arab Issues (IATF) is a non-partisan resource center on Arab citizens and Jewish-Arab relations in Israel that provides educational services tailored for American Jewish organizations. Through programs, publications, and partnerships, IATF promotes American Jewish discourse and engagement on these issues that are informed by the complex realities, trends, and developments on the ground.

In 2022, IATF continued to focus on strategic partnerships that integrate issues facing Arab citizens into the fabric of major American Jewish organizations. Since our founding in 2006, overall awareness of Arab minority issues has grown. Today, key organizations seek to promote Arab socio-economic development, fund shared society efforts, or to bring these issues into the field of Israel education. By providing resources, training, and learning opportunities, IATF helps these organizations model best practices for American Jewish engagement and expand our overall impact on American Jewish discourse.

# A MESSAGE FROM OUR LEADERSHIP

IATF was created by a leadership coalition in 2006 to raise American Jewish awareness about Arab citizens of Israel. Then, as it is now, our mission has been driven by a commitment to Jewish peoplehood, democratic values, and a vision of Israel that fulfills the promises of its Declaration of Independence.

Since its founding, IATF has been strengthening ties between two communities with many shared and overlapping values: American Jewish leaders, organizations, and funders, and the growing field of Israeli leaders, officials, and organizations working to reduce inequalities and foster more inclusive and resilient relations between Jewish and Arab citizens.

Over the years, enormous strides have been made in enhancing Arab citizens' access to higher education, to the labor market, and to new levels of prominence in national politics. But these successes are still only an indication of potential. Political tensions, fluctuations in Jewish-Arab relations, high crime rates in Arab society, and flashpoints in the wider Israeli-Palestinian conflict challenge the vision of a more shared and cohesive society.

American Jewish communities, who care so deeply about Israel, are also challenged by these issues. More than ever, American Jewish leaders deserve opportunities to share in longstanding efforts to foster stronger Jewish-Arab relations that contribute to a vision of a secure, diverse, and cohesive Israeli society.

IATF's work of connecting American Jewish leaders with trusted, professional insights on the Arab minority and experts in the field could not be more important.

# **2022 IN REVIEW**

2022 was pivotal year for Jewish-Arab relations in Israel. It began with a government that included the first-ever Arab party (Ra'am) in a coalition and saw the advancement of multiple budgets for Arab socio-economic development. The year ended with new elections following that government's dissolution. A new coalition was formed with far-right parties that were voted in following muscular, anti-Arab campaigns. The new reality cast uncertainty on budget implementation, Arab political participation, and on shared society trends moving into 2023.



Budgets. GR-550 (the NIS 30 billion socioeconomic development plan approved in late 2021) began implementation in 2022, with advances felt in transportation, urban planning, employment, higher education, and education, to name a few. Also known as "Takadum", this plan is a framework for an array of budgets including a NIS 5.2 billion plan for Negev Bedouin and a first-ever plan for Arab residents of mixed cities. In addition, the government passed a NIS 2 billion budget in response to crisis-level crime rates in Arab society which combine a focus on prevention and on increased law enforcement.

Shared Society. In the wake of the violent events of May 2021, overall focus on advancing shared society in Israel grew on national, local, and civil society levels. In 2022, for example, the Ministry of Education established recommendations for advancing shared living in the public education streams. The Ministry of Negev Galil budgeted shared society projects to strengthen the social fabric in mixed cities. Major civil society organizations initiated or expanded efforts to develop shared living capacities among Israeli Jews and Arabs.

Political Discourse. The Bennett-Lapid government functioned across significant differences but was weakened as pressure mounted on both right-wing and Arab MKs against making concessions. The government fell after failing to renew legislation extending Israeli Law for Israeli settlers in the West Bank. Meanwhile, right-wing opposition to Jewish-Arab political partnerships grew and became a source of increased support for ultra-right-wing parties at the end of 2022.



# **FOUNDATION FORUM**

**AS GOVERNMENT** investments in Arab socio-economic development grew over the last decade, so did the partnerships between government offices, NGOs and philanthropy. In 2022, IATF Foundation Forum met national and local government officials, civil sector experts, researchers, and thought-leaders to hear their insights into priorities and program developments in the field.

# **PARTNERSHIPS**

In recent years, IATF focused on strategic partnerships that anchor in-depth, data-rich learning within organizations that influence American Jewish discourse and engagement with Israel. In 2022, those flagship partnerships were with the iCenter and the Boston-Haifa Connection of the Combined Jewish Philanthropies.

iCenter: IATF worked closely with iCenter professionals to develop learning resources for educators.

- Complex Identity seminar. A module now part of the iCenter's experiential education certificate program, including meeting and discussion with Arab presenters.
- Companion resources: A co-branded infographic fact sheet, residency chart, and source sheet are regularly distributed, updated, and used in a wide variety of educator trainings.

**CJP Boston-Haifa Connection:** sought a facilitated strategic learning and planning process on building shared society in Haifa:



Through in-person, hybrid, and in-the-field programs, IATF introduced Jewish and Arab experts on shared society, mixed cities, political partnership, economic development, housing and planning, access to employment and the start-up nation, and more, to diverse American Jewish audiences.
