THE TASK FORCE IN 2024

Throughout 2024, the Task Force on Arab Citizens of Israel focused its activities on responding to the changing needs of our constituencies as they contend with wartime crises. In what ways could bringing Arab citizens' voices and perspectives to American Jewish audiences be most constructive during this polarized and sensitive time?

Arab citizens of Israel endured trauma, rocket fire, economic strain, and gaps in emergency response while also contending with an ongoing crime crisis. Many have played essential roles in Israeli institutions and services, contributing to resilience and recovery efforts. At the same time, Arab citizens carried the complex and often unspoken pain of both Israelis and Palestinians. American Jews, mourning the events of October 7 and deeply concerned for Israel, grappled with rising antisemitism and profound divisions over the war.

For American Jewish communities, hearing from Arab leaders and changemakers from Israel provided opportunities to share grief and a mutual need to countenance the war's complexities and envision ways forward together. These conversations illuminated new perspectives and fostered more constructive discourse during a highly polarized time. For funders sending emergency aid to Israel, learning about Arab citizens' needs and the impact of war on Jewish-Arab relations enabled giving across Israeli society and in support of preserving its social fabric into the future.

From calls on emergency needs in Arab communities, to the ten-day US tour of our inaugural cohort of Speaker Fellows, to our largest Annual Meeting to date, we met American Jewish communities that were curious, concerned, and seeking to learn and engage. Delving together into Israeli realities that are anything but black-and-white felt essential for American Jews and Arab citizens alike.

In 2024, we grew our programs and invested in our own and our partners' capacities to connect American Jewish audiences with Arab changemakers from Israel. In 2025, we seek to expand our reach to bring these discourses, shared challenges, and hopes into wider American Jewish networks and communities.

- The Task Force on Arab Citizens of Israel promotes American
 Jewish engagement with Israel that includes the complex realities and current
 developments affecting Arab communities and Jewish-Arab relations on the ground.
- OUR WORK. Through programs, trainings, partnerships, publications, and access to leaders and changemakers, the Task Force helps make these issues a strategic and impactful part of American Jewish philanthropic, educational, and communal engagement with Israel.
 - OUR GROWTH. Already prior to Oct 7, 2023 we recognized that rising engagement and interest from our educational and philanthropic partners required us to plan strategically for our growth as an organization. The dramatic changes brought on by war only increased the need to build our capacities to respond to new levels of complexity and urgency among both existing and new partners. Alongside our ongoing production of programs and resources, we:
 - **Expanded our capacity-building activities** including a new initiative to bring more Arab locations in Israel into the educational travel ecosystem.
 - Completed the training period of the Speaker Fellowship and launched the speaker bureau portion the program, which has already significantly increased the overall number of programs we've run in 2025.
 - Joined UpStart Laboratory's Growth Stage Accelerator, UpSpring '25 whose resources and supports are helping us strengthen our internal systems, identify adaptive growth challenges and opportunities, and further scale our reach.

NAME UPDATE



In line with our growth, we recognized the importance of clarifying the name of our organization while retaining our identity. Our transition from the Inter-Agency Task Force on Israeli Arab Issues to the Task Force on Arab Citizens of Israel simplifies and modernizes our name. It emphasizes our focus on citizenship while adopting more appropriate terminology for the field.

PHILANTHROPY

In 2024, funders were contending with cumulative crises. War, polarization, budget cuts, policy changes, and unabated crime in Arab communities put unprecedented strain on the field seeking to ensure Arab citizens are part of emergency and rehabilitation efforts.

Working closely with partners like SVF, JFN, federations and field organizations, the Task Force provided hundreds of funders with timely insights into priorities and needs on the ground, and access to leaders forging strategic paths forward in a rapidly changing and challenging context.

Philanthropy continues to be a driving force behind Arab and Jewish-Arab initiatives in Israel.

ISRAEL EDUCATION

In 2024, we worked closely with partners in the Israel education field to help meet new challenges following Oct 7. Through curated speaker programs, trainings, and new resources, we brought nuanced insights and perspectives from Arab society to hundreds of educators and learners.

To bridge a longstanding gap in experiential Israel education, we hired an Educational Programs Developer to connect sites in Arab communities to the educational travel ecosystem. Preparing sites for field encounters with young American Jews will not only meet growing demand for such content, it provides a new source of exposure, professional development, and revenue to host organizations and communities in Arab society.

Educational travel partners increasingly have been prioritizing opportunities to meet Arab leaders and witness shared society initiatives firsthand. In 2024, the Task Force organized our first two field days for Hebrew Union College and UJA Federation of New York in Kfar Kassem and Jaljuliya. We are working with partners and the municipalities to build capacity for regularly hosting groups.



The idea for the Speakers Fellowship, which prepares next generation changemakers from Arab society to learn about, speak and engage with American Jewish organizations, emerged in 2022 based on needs articulated by Israel education partners. Following October 7, 2023, the program became more timely than we could have anticipated. We are proud of how the Speakers Fellowship has become a source of agency, nuance, and even hope for Fellows, program partners and participants.

KEY MILESTONES IN 2024









- In 2024 the Fellows completed the training phase of the program and embarked on a 12-day speaking and learning tour in the United States. The Fellows spoke at 17 events with 12 different partners, reaching 514 participants. The programs spanned synagogues, community centers, federations, living rooms, bars, foundation offices, and more.
- From July 2024 to July 2026 the Fellows are part of a speaker's bureau, available to a range of learners—virtually, in person, and on experiential programs and mission visits to Israel. In 2024, our speakers were in 18 programs, reaching 649 participants with 15 partner organizations.

POST-PROGRAM EVALUATION INSIGHTS

73%

of participants felt "more optimistic about having constructive conversations about Israel across differences."

96%

of participants were glad they attended, and many emphasized the event's importance for the wider community.

5 out of 7

Fellows said the Fellowship provided space for self reflection post 10/7 and that it strengthen their understanding of their own identities.

RESOURCES & PUBLICATIONS

In 2024, the Task Force expanded its resource suite with infographics and movie guides designed to enrich learning and engagement with Arab society in Israel. These resources support educators, program professionals, and diverse audiences—whether as part of structured programs, standalone learning, or broader curricula. Task Force resources have been distributed at the IETA Conference, JFN gatherings, the Other Israel Film Festival, and on platforms like the Jewish Education Project and the iCenter, a broad network of Jewish educators and learners.

2024 ANNUAL MEETINGS

Over 130 participants from a range of organizations and foundations gathered for the Task Force's Annual Meetings in December.







This year's meetings featured a record number of Arab and Jewish speakers, enabling diverse voices, topics and connection opportunities. Through plenaries, breakouts, and roundtable discussions, American Jewish leaders, funders, and professionals explored urgent issues with partners from the field.

Breakouts spanned the conditions of Arab communities in the south and north, the persistent crisis of crime and violence, and the role of shared society leaders. Roundtables focused on what these realities mean for American Jewish communities grappling with Israel at war.

FOUNDATION FORUM: The following day 50 funders participated in in-depth learning about emergency response and preparedness capacities in Arab society, as well as and long-term field-building approaches to social and economic resilience for the "day after."

POST-PROGRAM REFLECTIONS

We asked participants 'Based on today's sessions, what new knowledge or action will you carry forward into your work?'

I have a much greater awareness of the different issues Arab Israeli communities are facing and their systemic impact.

FINANCIAL RESOURCES

In 2023 and 2024, the Task Force continued to diversify our revenues through capacity building and program grants.

Grant funded programs include the Speaker Fellowship, and our work bringing Arab society into the educational tourism ecosystem. Support from UpStart is allocated towards strategic growth.

Member dues provide by far our largest portion of our core operating budget. New members and dues increases are vital to sustain our growing portfolios.

Annual dues from a wide coalition of American Jewish organizations also reflect the shared commitment to Arab citizen issues as a mainstream part of the American Jewish connection to Israel.
