THE TASK FORCE IN 2025

In 2025, the long-awaited return of hostages and a ceasefire agreement brought two years of ongoing war to a fragile close. Along with great relief, the uncertain path ahead held many questions about the future of Arab citizens and Jewish-Arab relations in Israel's recovery.

For Arab citizens of Israel, the war in Gaza intensified the profound tension of belonging to a state at war with a people to whom they are also deeply connected. Polarization and mistrust remain high between Jewish and Arab communities, affecting Arab citizens' sense of horizon and hopes for a shared and equal future. **For American Jews**, the challenge of holding complexity, maintaining cohesion, and staying connected to Israel across divisions reshaped Jewish communal life.

Most of the Task Force's work in 2025 focused on ensuring that Arab citizens are included as an essential part of the American Jewish connection to Israel and seen as vital partners for its resilience and recovery. We brought leading voices to speak with funders about efforts to expand emergency preparedness and response capacities in Arab communities, prevent the defunding of government socio-economic development budgets (GR-550), and to explore challenges and opportunities for a shared recovery.

Our Israel education portfolio grew rapidly in response to urgent needs for programs, pedagogy, and training that respond to American Jewish learners' interest in multivocal perspectives that cut through zero-sum discourse on Israel. Our first cohort of trained Fellows, and a new initiative to develop sites for Israel educational travel, enhanced access to Arab changemakers and generated dozens of programs and trainings despite war-related disruptions.

Across these portfolios, we strengthened existing partnerships and forged new ones. We accelerated our efforts to serve communal and rabbinic leadership with designated programs, engagement, and a rabbinic internship, and developed new approaches to elevating Arab citizens voices in the context of the ongoing conflict. At our Annual Meetings in November, Arab citizens discussed their stake as partners in Israel's future in the region, creating an opportunity for American Jews to explore their own stake, and consider what is lost when divisions silence underlying issues, values, and fears.

Looking ahead, our goal is to expand and strengthen the ways in which different American Jewish constituencies can connect with Arab citizens of Israel around shared needs to create a better and more hopeful future.

PHILANTHROPY

For nearly five years, funders have operated in a sustained state of emergency. From COVID-19 through two years of war, the Task Force has supported philanthropy in understanding how compounded crises uniquely affect Arab communities and which interventions are most effective. This work, carried out with partners such as SVF, JFN, JFNA, COP and ALLMEP, has helped ensure Arab society remains an integral part of emergency and recovery giving in Israel. Looking ahead, we will continue connecting funders with innovative leaders and initiatives on the ground, supporting more informed and strategic philanthropy amid ongoing crisis and uncertainty.

ISRAEL EDUCATION

In recent years, the Task Force has focused on strengthening its work in the Israel education field by contributing content expertise and pedagogical support to institutions that shape how American Jews learn about and engage with Israel. Through partnerships with dozens of organizations, we have worked to expand access to high-quality programs and voices from Arab society in Israel, while supporting educational approaches that are meaningful for educators, learners, and changemakers alike.

SPEAKERS FELLOWSHIP

COHORT 1: In 2025, the pilot cohort completed the first year of a two-year speakers bureau. Despite significant war-related disruptions, **We organized 26 Fellows programs with 20 partner organizations, reaching 845 participants.** Programs took place across a wide range of settings, including synagogues, community centers and federations in the U.S and at NGOs, hotels, museums, and community spaces across Israel.

COHORT 2: In 2025, we recruited the **second Speakers Fellowship cohort, comprising nine emerging changemakers from Arab society.** The Fellows represent diverse communities from the Galilee to the Negev. Each is making an impact in their communities across civil society, journalism, social entrepreneurship, tech, sports, and environmental initiatives. The Fellowship kicked off with an in-person retreat in January 2026. A U.S. speaking tour is planned for early May 2026.




ISRAEL EDUCATIONAL TRAVEL ECOSYSTEM

SITE DEVELOPMENT, PROGRAMS, AND TRAININGS

The Task Force envisions a future in which educational experiences with Arab citizens are integral to Israel education travel and a valued platform for Arab communities and organizations. To meet growing demand for such experiences, we are building partnerships and developing sites in Arab society that are ready to share their realities and visions with American Jewish learners. These efforts made **Israel educational travel our fastest growing programmatic portfolio.**

➔ **9** curated learning experiences in Arab communities and shared society in Israel

The Task Force **curated a catalogue of learning experiences** with Arab communities and shared society organizations. It currently includes nine sites for experiential programs based on geographic accessibility, presence of local speakers and guides, and facilities that can physically accommodate groups. We orient these organizations and speakers on the goals and logistical needs of American groups, explore how they could benefit from these opportunities, and prepare them to share their stories with sincerity and integrity. Task Force staff align expectations between visiting groups and our partners, ensuring that speakers have space to share what is most important to them. This growing catalog is now an educators' resource for high-quality programming with Arab society.

CATALOG OF LEARNING EXPERIENCES WITH ARAB CITIZENS



Catalog Spotlight: Kfar Qasem Hub | 6 Programs in 2025

Located in the center of Israel and with a robust civil society, Kfar Qasem emerged as a strategic hub for learners to experience an Arab city first-hand. We built a strong partnership with the local AJEEC gap year movement, Tzofen-Tashbik, the Klika tech and entrepreneurship hub, and the municipality, to grow capacity and interest in increasing local educational tourism.

In 2025 the Task Force deepened our work across the Israel educational travel pipeline. We partnered with American trip organizations, Israel-based tour operators, and worked with educational guides to prepare and connect them to relevant sites and experiences. By preparing educators, providing educational framing, and supporting program facilitation, we reduce barriers to programming and ensure that encounters in Arab society are meaningful and informative for a range of learners.

FIRST EDUCATORS' CONVENING



At our 2025 Annual Meeting we held our **first dedicated educators' convening**. Our presentation and discussion focused on pedagogical frameworks for integrating content about Arab citizens into Israel education in a post October 7th reality.



PUBLICATIONS & RESOURCES

In 2025, the Task Force continued to produce timely updates and resources to enrich learning and engagement with Arab society in Israel. These resources support educators, program professionals, and diverse audiences—whether as part of structured programs, standalone learning, or broader curricula. Task Force resources have been distributed at the IETA Conference, J2 trainings, JFN gatherings, the Other Israel Film Festival, and among a broad network of Jewish educators and learners.

2025 ANNUAL MEETINGS: BETWEEN CRISIS AND HOPE

Over 120 participants and speakers from a range of organizations and foundations gathered for the Task Force's Annual Meetings in November.



This year's meetings featured a record number of Arab and Jewish speakers from Israel discussing the impact of the war on vital aspects of Arab society and Jewish-Arab relations. Through keynotes, breakout sessions, personal stories, and panel discussions, meeting topics spanned socio-economic realities, experiences of Arab youth, political participation, and rebuilding trust in Jewish-Arab relations. The program culminated with a panel and workshop inviting participants to explore the unique stakes of Arab citizens and American Jews as stakeholders in the conflict and the region's future.

That evening, we hosted **the first Educators Convening**, providing a dedicated space for Israel education professionals to process the day's content and consider how to bring these conversations into their areas of work.

On November 6, **the Foundation Forum Annual Meeting** delved deeper into the status of national efforts to narrow socio-economic gaps, opportunities to ensure Arab citizens are part of Israel's recovery, and the role and potential of local authorities to strengthen Arab communities from the ground up.



FINANCIAL RESOURCES

In 2025, the Task Force continued to diversify and grow our revenues through capacity building and program grants.

Grant-funded programs include the Speaker Fellowship and our work bringing Arab society into the educational tourism ecosystem. Accelerator funding from UpStart supported our strategic growth.

Member dues from a wide coalition of American Jewish organizations continue to provide the largest portion of our operating budget. They reflect the shared commitment to Arab citizen issues as a mainstream part of the American Jewish connection to Israel.

New members and dues increases are vital to sustain our growing portfolios.



